### **Delegation of Rights**



2021 DELEGATION OF RIGHTS are due by January 31st. A current Delegation of Rights must be on file in the clubhouse for any renters wanting to use the pool or rent the clubhouse. These forms were mailed to the owners and need to be updated on an annual basis. No pool passes or clubhouse rentals will be issued to renters without a current form on file.



### Paid Assessment Letters are <mark>Required</mark> to Sell Your Home

When selling your home, please have your attorney request a paid assessment letter at least five business days in advance of your closing. The cost of the paid assessment letter is \$40.00. If you need it sooner, a \$20 fee will be added. The request must be in writing and come from your attorney. ### Clubhouse Rentals



All Clubhouse rentals are cancelled until further notice. Full refunds will be given.

#### **Fences**



All fences along common areas, whether new or replacements must be approved by the Board of Directors prior to being constructed or repaired.

#### Article 7.09 of the Steeple Run Declaration of Covenants:

7.09 Alteration of Dwelling Units: No Dwelling Unit Owner shall relocate, heighten, lower or otherwise move, change or construct any fence, wall or patio adjoining or adjacent to the "Common Area" unless consented thereto by the Board of Directors at a Special Meeting called for that purpose. A resolution passed by said Board and signed by the presiding officer shall be procured prior to the commencement of any construction, alteration or change.

#### **Christmas Tree Pick-Up**

Lakeshore Recycling Systems offers free recycling of live Christmas trees during the first two weeks of January. Trees must be free of tinsel and ornaments and should not be placed in plastic bags. Flocked trees, plastic trees, wire trees and trees with bulbs, lights or tinsel will not be collected.

#### **Holiday Lights**

Residents who would like to recycle an unlimited amount of old, broken or unwanted strands of holiday lights can bring them to the Village Hall Lobby (925 Burlington Ave), through Friday, January 29, 2021 from 7 AM to 4:30 PM. Accepted lights include mini-lights (or Italian lights), C7 lights, C9 lights, rope lights, LED lights and extension cords, all free of charge. Garland, wreaths and outdoor display pieces containing lights will **not** be accepted.





#### Snow Removal

PARKING restrictions during snowfalls have been reduced to ONE INCH. Vehicles are to be removed from Township streets after one (I ") inch of snowfall. Any vehicle remaining parked on streets after one (I ") inch of snowfall is subject to being ticketed. The ordinance also mandates that the parking ban stay in effect for 24 hours after the snowfall so the streets can be cleared.
