

BACKYARD CHICKENS

The Steeple Run Community Council is not responsible for governing any relevant zoning or permit requirements pertaining to backyard chickens. If all DuPage County and/or City of Naperville guidelines are being followed, we urge residents not to concern themselves with a neighbor's private affairs.

RODENT CONCERNS

In the past, SRCC has received complaints about possible rodent sightings. Food like bird feeder seed and water sources like bird baths should be maintained properly to mitigate rodents. The Illinois department of Health states, "Foods should be kept in sealed containers made of materials difficult for rodents to chew through, such as metal and hard plastic. Trash also should be stored in tightly sealed containers including trash cans and dumpsters with lids".

Proof of residency is required in the form of a valid ID or current bill issued to your address for new passes. Tenants in the Steeple Run neighborhood may obtain a pool pass if there is an updated Declaration of Rights form on file. To renew your pass, you may send in a current photo with your name and address to the steeple run email or stop in to get your picture taken. Please call the Office with any questions.
