## Leaf Pickup



- Rake leaves onto the parkway between the sidewalk and the curb, or between the ditch line and the edge of the road.
- Do not mix branches or other yard waste with leaf piles
- Do not place leaf piles behind parked cars
- Do not allow leaves to clog ditches or storm drains
- Do not put leaves in bags

**Leaf pickup for the 2023 fall season starts Monday October 16th.**

**Monday November 20th before 6:30AM is the last time to put leaves in the parkway.**
