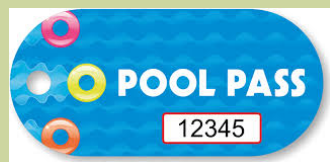

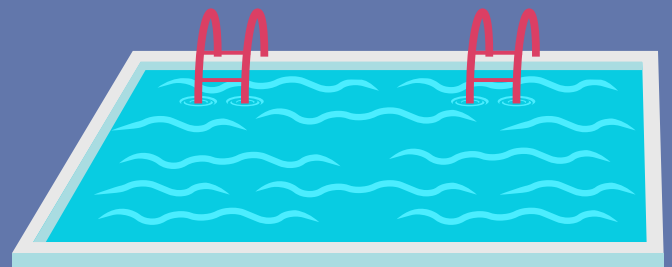

Hop on over to our annual Easter Egg Hunt! Join us for a day of family fun as we search for colorful Easter eggs hidden around the clubhouse.

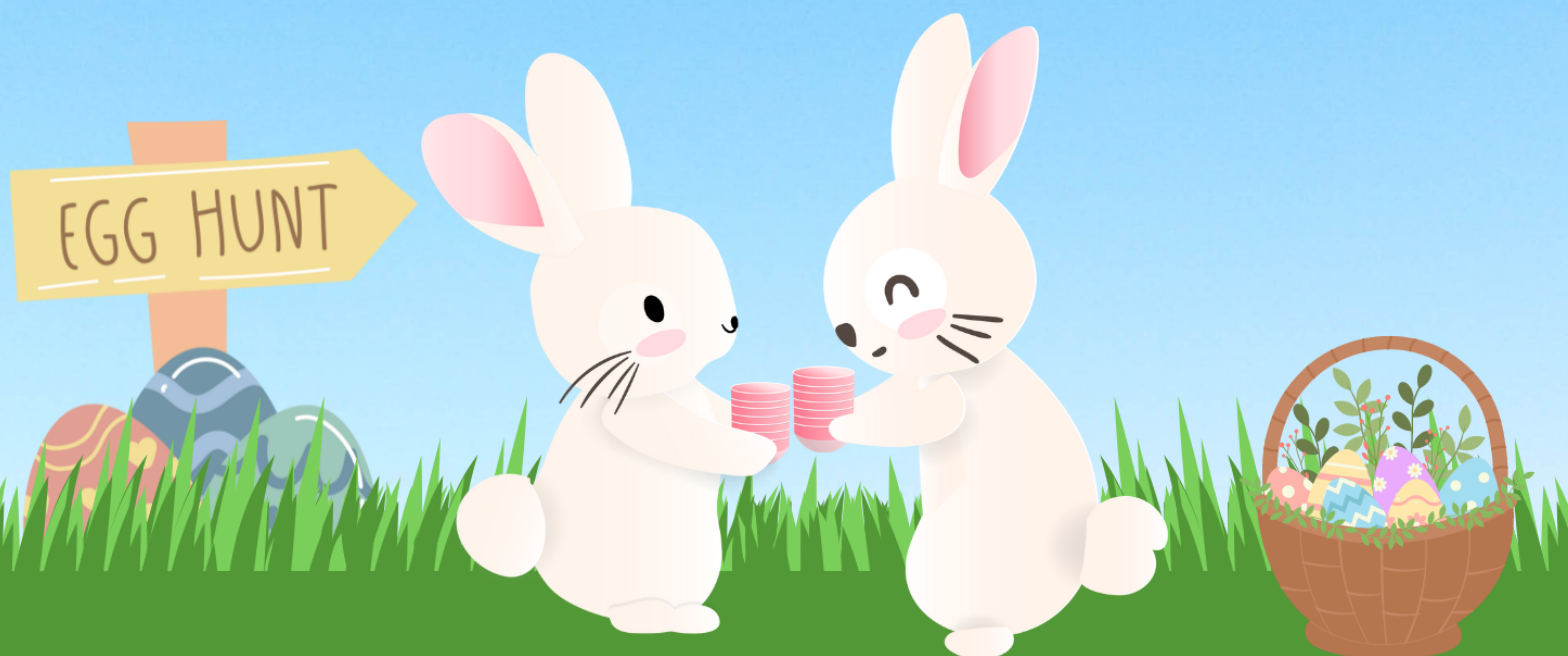
